Home from hospital: how housing services are relieving pressure on the NHS

Making the economic case for investing in actions to prevent and/or tackle loneliness

London School of Economics have provided a [systematic review](#) of evidence for [The Campaign to End Loneliness](#) around loneliness experienced by older people found that interventions fall into three broad groups: befriending, face to face and telephone services; participation in social and healthy lifestyle activities; and signposting/ navigation services. Economic evidence for these interventions is mixed but modelling suggests that signposting / navigation services can generate a positive return on investment of £2 to £3 per £1 invested over five years.

New figures reveal teenage girls are more likely to self-harm than boys

There has been a rise in reports of self-harm among girls aged 13 to 16, according to a study of data from GP practices across the UK. The [BMJ study](#), *Incidence, clinical management, and mortality risk following self-harm among children and adolescents: cohort study in primary care*, looked at figures from 2011-2014, and said GPs could be getting better at picking up self-harm. But it was likely that rising stress and psychological problems in young people were also behind the trend

Social work's role in tackling loneliness

There is a growing evidence base around the challenges associated with loneliness and social isolation, and the role social workers have to play in tackling these issues. Loneliness is defined as a subjective feeling of lacking social connection, while social isolation refers to the objective measure of our ties to other people. Both bring profound health risks and can impact on our physical and mental health in ways comparable to health hazards such as obesity, smoking and cardiovascular disease. Factors such as income, education level, socioeconomic status and living in rural or deprived communities can all increase the social isolation of older people. The experience of loneliness and social isolation is also often associated with loss. As people age, loss becomes incremental - loss of partner, health status, life role. Latest NCMP data show obesity in reception children rises again

[New figures from PHE's National Child Measurement Programme \(NCMP\)](#) show obesity rise for second year in a row in reception year children in 2016 to 2017.

National Child Measurement Programme (NCMP) trends report

[Risk factors intelligence has published the latest National Child Measurement Programme \(NCMP\) trends report](#) and discusses the changes in children's body mass index between 2006/07 and 2015/16. The report explores trends in obesity, overweight, excess weight and underweight prevalence, as well as changes in mean BMI over time. The report shows that obesity is stabilising in Reception girls and there is a downward trend in obesity in Reception boys. In Year 6 however, there is a significant upward trend in obesity among both boys and girls. Inequalities continue to widen between the most deprived and least deprived children across both sexes and year groups. For the first time, the report also maps the trends of childhood obesity across local authority areas.

Hate Crime, England and Wales 2016/17

The Home Office has published a statistical bulletin on [hate crime](#). In 2016/17, there were 80,393 offences recorded by the police in which one or more hate crime strands were deemed to be a motivating factor. This was an increase of 29 per cent compared with the 62,518 hate crimes recorded in 2015/16, the largest percentage increase seen since the series began in 2011/12.

Housing: Living the dream

[Resolution Foundation](#) report for the [Intergenerational Commission](#) looks at the topic of housing. They compare the housing outcomes achieved by different generations over the life course and assess the extent to which intergenerational inequalities exist when it comes to security, to affordability and to quality. Stolen freedom: the policing response to modern slavery and human trafficking

This [report](#) from Her Majesty's Inspectorate of Constabulary and Fire & Rescue Services (HMICFRS) is the result of the first thematic inspection on this topic since the introduction of the Modern Slavery Act in 2015. The report concluded that there were signs of progress in the policing response to modern slavery. However in too many cases, police work was reactive and showed little understanding of the nature and scale of modern slavery and human trafficking.

Measures from the Adult Social Care Outcomes Framework, England - 2016-17

This [report](#), from NHS Digital, focuses on the main findings for each measure in the Adult Social Care Outcomes Framework (ASCOF) in 2016-17. The ASCOF measures how well care and support services achieve the outcomes that matter most to people.

The roll-out of Universal Credit

Universal Credit (UC) is a new benefit which is to replace means-tested social security benefits and tax credits for working-age individuals and families. The aim is to simplify and streamline the benefits system, improve work incentives, tackle poverty among low income families, and reduce the scope for error and fraud. UC was first introduced for a small subset of new claimants in certain areas in 2013, and is gradually being rolled out to new claimant groups. The benefit is not expected to be fully introduced until 2022. The House of Commons Library produced a [briefing paper](#) in March 2017 which describes the background, and evidence of problems. Crime in England and Wales: year ending June 2017

Including new Experimental Statistics on fraud and computer misuse offences, the [CSEW estimated 10.8 million incidents of crime in the latest survey year](#), but first annual comparisons will not be available until January 2018. The police recorded 5.2 million offences in the latest year; this series can provide a better indication of emerging trends but can also reflect changes in recording practices and police activity rather than genuine changes in crime. The 13% increase in police recorded crime from the previous year reflects a range of factors including continuing improvements to crime recording and genuine increases in some crime categories, especially in those that are well-recorded. The new presentation of official statistics on violent crime highlights there were 711 deaths or serious injuries caused by illegal driving, a 6% rise from that recorded in the previous year. A number of sources showed a rise in bank and credit card fraud in the last year; UK Finance reported a 3% rise in the volume of fraudulent transactions reported on UK-issued cards.

Child abuse and neglect

[This guidance from the National Institute for Health and Care Excellence \(NICE\)](#) covers recognising and responding to abuse and neglect in children and young people aged under 18. It covers physical, sexual and emotional abuse, and neglect. The guideline aims to help anyone whose work brings them into contact with children and young people to spot signs of abuse and neglect and to know how to respond. It also supports practitioners who carry out assessments and provide early help and interventions to children, young people, parents and carers.

Thriving at Work: a review of mental health and employers

An [independent review](#) of mental health and employers has been published by Lord Dennis Stevenson and Paul Farmer. Research was carried out by Deloitte. [Thriving at Work](#) sets out what employers can do to better support all employees, including those with mental health problems to remain in and thrive through work. Poor mental health costs employers between £33 billion and £42 billion a year. The review quantifies how investing in supporting mental health at work is good for business and productivity. The most important recommendation is that all employers, regardless of size or industry, should adopt 6 'mental health core standards' that lay basic foundations for an approach to workplace mental health.

General Data Protection Regulation (GDPR) guidance

[General Data Protection Regulation \(GDPR\) guidance](#) is being developed by the national GDPR working group. This will help organisations make the changes needed due to the EU General Data Protection Regulation.

Sector-led improvement for public health, prevention and early intervention

The LGA is working with partners at PHE, and the Association for Directors of Public Health to deliver [sector-led improvement activity](#) in 2017/18 for public health, prevention, and early intervention through the DH care and health improvement programme (CHIP). This prospectus sets out the programme support available through the LGA and partners

Cancer patients diagnosed early are more likely to avoid chemotherapy

Cancer patients [are around five times more likely to have surgery to remove their tumour, and less likely to have chemotherapy](#), if they are diagnosed at the earliest stage compared to the latest stage. This is the first time researchers have been able to show whether NHS patients received surgery, chemotherapy and radiotherapy, alone or in combination, linked with their cancer stage. Cancer Research UK and Public Health England examined data from about half a million patients with 22 different cancer types in England between 2013-2014. It shows that 7 in 10 (70%) diagnosed at the earliest stage (stage 1) had surgery to remove their tumour. This falls to around 1 in 10 (13%) of those diagnosed at the latest stage (stage 4).

[Analysis from the Royal College of Psychiatrists](#) shows that 33 Clinical Commissioning Groups spent near to £35 per head on mental health for young people in 2016/17 whilst others, including Wirral, spent closer to £70 per head

Building connected communities

[Building Connected Communities](#), a new report from LGiU (Local Government Information Unit) and the Ramblers, investigates the challenges that councils experience in building healthy, connected, walkable places. The research shows that local authorities want to build places that encourage walking and active travel, but developers do not always share these priorities. Many councils feel the mismatch is a challenge in achieving their goals. A survey of 118 officers from local authorities across England and found that eighty nine per cent say walking access is a key consideration for their council and ninety four per cent have a Local Plan in place that encourages walking and active travel. However, only forty nine per cent felt developers share the same priorities. [Press release](#)

Birth characteristics in England and Wales: 2016

[Birth characteristics across England and Wales](#) saw 696,271 live births in 2016, of which 49% were girls and 51% were boys. The percentage of women giving birth at home was 2.1% in 2016, a small decrease compared with 2012 to 2015 when it was 2.3%. 10,951 mothers had a multiple birth in 2016; 10,786 women had twins, 160 had triplets and 5 had quads and above (multiple births include stillbirths).

Minimum Unit Pricing of alcohol

The Welsh Government has announced plans to see Minimum Unit Pricing (MUP) introduced by law. However it has not yet stated the intended price level. Scotland introduced legislation in 2012, but implementation has been delayed due a challenge in the courts. The UK Supreme Court decision is expected soon. In England, fifty health bodies and other figures including MPs have called on the Government to follow suit and enact UK wide minimum pricing, describing MUP as a 'highly effective tool'. Effect of non-dependent parental drinking on children and families

A new [report](#) published by the [Institute of Alcohol Studies \(IAS\)](#) in partnership with the Alcohol and Families Alliance and Alcohol Focus Scotland draws on data from a nationally representative online survey of almost 1,000 parents and their children, focus groups and a public inquiry involving experts and practitioners. The report shows that parents do not have to regularly drink large amounts of alcohol for their children to notice changes in their behaviour and experience negative impacts. Having seen a parent tipsy or drunk was associated with children feeling worried as well as experiencing at least one of a range of negative impacts, including feeling less comforted than usual, facing more arguments, unpredictable parental behaviour and disrupted bedtime routines.

Depression in children and young people: identification and management

Updated [NICE guidance](#) (CG28) has been produced on identifying and managing depression in children and young people aged between 5 and 18 years. Based on the stepped care model, it aims to improve recognition and assessment and promote effective treatments for mild, moderate and severe depression

End of life care for infants, children and young people Quality Standard [QS160]
